- Door to Door garbage collection will be done every day without break during the work execution in the proposed roads.
- It was explained to the Public that during the work execution construction management measures will be followed and project will be implemented without any disturbance to the Public.

- The Commissioner assured that the road Renovation works will be completed within the stipulated time.
