ORDER:

1. In G.O.Ms.No.24, M&WS., dated 23.1.91, the Government published for criticism the proposal to constitute a Municipality second grade for the area within the jurisdiction of Hosur Town Panchayat (Selection Grade) in the Dharmapuri District. Tmt. Jeejababu Jayaramiah has objected to the propos'l. The Government overrule the objection raised by Tmt. Jeejababu Jayaramiah and direct that a Municipality (Second Grade) be constituted with effect from 15.01.92 for the area referred to above.

2. Under Section 7(1) of the Tamil Nadu District Municipalities Act, 1920, (Tamil Nadu Act V of 1920), the total number of Councillors of the new Municipality will be fixed at twenty six.

3. Order regarding the appointment of a Special Officer for the Municipality under section 36B of the Tamil Nadu District Municipalities Act, 1920 (Tamil Nadu Act V of 1920) will be issued separately. The Commissioner of Municipal Administration is requested to send necessary proposals to the Government.

4. Under sub-section (5) of section 4 of the Tamil Nadu District Municipalities Act, 1920 (Tamil Nadu Act V of 1920), the Government direct that the markets, fairs, Maternity and Child Welfare Centres and such other items or institutions, if any, which are under the jurisdiction and within the limits of the present Hosur Town Panchayat (Selection Grade) and which shall hereafter be statutorily maintained by the Municipality according to the actual location shall be transferred to the Hosur Municipality (Second Grade) with effect from the 15th January 1992.

- (1) The maintenance of the institutions transferred to the new municipality and the payment of salaries of the staff excluding teaching and non teaching staff

of the schools should be met from the funds of the municipality. They will be eligible for the Government grants payable for the maintenance of educational institutions and Maternity Child Welfare Centres.

(2) The Government also direct that the entire staff in the Maternity and Child Welfare institutions as on 15.01.92 forenoon shall be transferred from the Town Local Govt Service to the Municipal Service with effect from the 15th January 1992.

(3) The attention of the Collector of Dharmapuri is invited to section 3(4) of the Tamil Nadu Panchayats Act, 1958 (Tamil Nadu Act XXXV of 1958) in regard to the disposal of the properties vested in the Panchayat which has ceased to exist and the discharge of its liabilities. He is requested to transfer the properties with assets and liabilities to the Municipal Council to be constituted.

(4) If there are any difficulties on the actual transfer of assets and liabilities, the Collector should bring them to the notice of the Government.

(5) The Commissioner of Municipal Administration is empowered to create necessary essential posts as per norms while Hosur Municipality second grade is constituted.

(6) The Collector of Dharmapuri is permitted to incur any expenditure which will be necessary for the inauguration of the new Municipality.

(7) The Special Officer, Hosur Municipality is requested to address the Government in the Education Department for release of maintenance grant for educational institutions. His attention is also invited to section 34 of the Tamil Nadu Elementary Education Act, 1920 which empowers the Municipal Councils to levy Education Tax with the prior concurrence of the Government. He is requested to send proposals to the Government in the Education Department for the levy of this tax.

5. The appended notifications will be published in English in the Tamil Nadu Government Gazette Extra-ordinary dated 7th January 1992 and in Tamil in the Dharmapuri District Gazette. The Director of Translation is requested to have the

NOTIFICATION I

In exercise of the powers conferred by sub-section (3) of section 4 of the Tamil Nadu District Municipalities Act, 1920 (Tamil Nadu Act V of 1920), the Governor of Tamil Nadu hereby declares that the local area now within the jurisdiction of the Hosur Town Panchayat (Selection Grade) in the Dharmapuri District, shall be constituted as a Municipality with the name "Hosur Municipality" (Second Grade) with effect on and from the 15th January, 1992.

NOTIFICATION II

In exercise of the powers conferred by sub-section (1) of section 7 of the Tamil Nadu District Municipalities Act, 1920 (Tamil Nadu Act V of 1920), the Governor of Tamil Nadu hereby notifies that with effect on and from the date of its constitution, namely, the 15th January 1992, the Hosur Municipal Council shall consist of twenty six councillors exclusive of its Chairman.
