NOTIFICATION.

In exercise of the powers conferred by sub-section (1) of section 30 of the Registration of Births and Deaths Act, 1969 (Central Act 18 of 1969), the Governor of Tamil Nadu with the approval of the Central Government, hereby makes the following amendments to the Tamil Nadu Registration of Births and Deaths Rules, 2000.

AMENDMENTS.

In the said Rules,-

(1) in rule 9, -

- (a) in sub-rule (1), for the words "rupees two", the words "rupees one hundred" shall be substituted.
- (b) in sub-rule (2), for the words "rupees five", the words "rupees two hundred" shall be substituted.
- (c) in sub-rule (3), for the words "rupees ten", the words "rupees five hundred" shall be substituted;

(2) in rule 10, in the proviso to sub-rule (1),-

- a) in clause (a), for the words "rupees five", the words "rupees two hundred" shall be substituted.
- b) In clause (b), for the words "rupees five", the words "rupees two hundred" shall be substituted;

(3) in rule 13, in sub-rule (1), for the tabular column, the following tabular column shall be substituted, nameiy:-

	Rupees
"(a) Search for a single entry in the first year for which the search is made.	100/-
(b) For every additional year for which the search is continued.	100/-
(c) For granting extract relating to each birth or death.	200/-
(d) For every additional copies of extract.	200/-
(e) For granting non-availability Certificate.	100/-."
