APPENDIX NOTIFICATION

In exercise of the powers conferred by section 138-A of the Tamil Nadu Public Health Act, 1939 (Tamil Nadu Act III of 1939), the Governor of Tamil Nadu hereby makes the following Rule:-

THE RULE

The offences punishable under sub-section (2) of section 76, of the Tamil Nadu Public Health Act, 1939 (Tamil Nadu Act III of 1939), as specified in column (2) of the Table hereunder are declared as compoundable for the amount specified in the corresponding entry in column (3) thereof.

	(ii) Spitting in Public Places.	500/- (Rupees five hundred only)
	(iii) Violation of social distancing norms by individuals in public places or gatherings as ordered by the appropriate authority from time to time.	500/- (Rupees five hundred only)
(3)	Violation of Standard Operating Procedures in salon and spa, gymnasium, commercial establishments or such other public places as ordered by the appropriate authority from time to time.	(Rupees five thousand only)
(4)	Non-adherence of the guidelines issued by the Government to be followed in containment zone:-	
	(i) by individuals	500/- (Rupees five hundred only)
	(ii) in respect of vehicles or commercial establishments	5000/- (Rupees five thousand only)
