From the Commissioner of Municipal Administration Letter No.7885/2019/MCA-1, dated 20.11.2019 and 13.08.2020.

#### ORDER:

The post of Junior Assistant-cum-Typist exists in Municipal Corporations (except Chennai). This post comes under Class III of Tamil Nadu Municipal Corporations General Subordinate Service Rules, 1996. In Government service, the post of Junior Assistant-cum-Typist has been bifurcated as Junior Assistant and Typist vide G.O.(Ms) No.174, Personnel & Administrative Reforms Department, Dated 08.09.2000.

- 2. In the letter read above, the Commissioner of Municipal Administration has sent proposal to Government to bifurcate the post of Junior Assistant-cum-Typist in Tamil Nadu Municipal Corporations General Subordinate Service Rules, 1996 as Junior Assistant and Typist and to fix the minimum educational qualification of S.S.L.C. for the post of Steno-Typist, Junior Assistant and Typist in line with the Tamil Nadu Ministerial Service Rules.
- 3. The Government after careful examination have decided to accept the proposal of the Commissioner of Municipal Administration to disband the post of Junior Assistant-cum-Typist so as to create the posts of Junior Assistant and Typist and also to fix the minimum educational qualification of S.S.L.C. for the post of Steno-Typist, Junior-Assistant and Typist in line with the Tamil Nadu Ministerial Service Rules by amending the Tamil Nadu Municipal Corporations General Subordinate Service Rules, 1996 and order accordingly.
- 4. The Commissioner of Municipal Administration is instructed to ensure that the total number of Junior Assistant posts and Typist posts now being created does not exceed the total number of Junior Assistant-cum-Typist posts to be disbanded/ extinguished in each Corporation.

5. The following appended Notification shall be published in the Tamil Nadu Government Gazette, Extraordinary, dated the 19<sup>th</sup> August 2020.

- (a) in column (3) against the corresponding entry "Assistant" in column (1), after entry (ii), the following proviso shall be inserted, namely:-
  - "Provided that five per cent of the estimated vacancies, in the category of Assistant in Corporation, shall be filled up by transfer from the post of Steno-typist, who has put in not less than eight years of service and opts for transfer as Assistant as on the 1<sup>st</sup> April of the year in which the selection is made.";
- (b) for the expression "Junior Assistant-cum-Typist" in column (1) and its corresponding entries in columns (2) and (3) thereof, the following entries shall, respectively, be substituted, namely:-

  - (i-a) By transfer from the holders of the post of Typist who have completed their probation";
- (4) for in rule 5, the following rule shall be substituted, namely:-
  - "5. Inter-se-Seniority between Junior Assistant, Steno-typist and Typist:- There shall be one common Seniority list in a corporation for the post of Junior Assistant, Steno-typist and Typist and the inter-se-seniority for the holders of the post of Junior Assistant, Steno-Typist and Typist shall be fixed based on the date of appointment to that post. If appointments to the posts of Junior Assistant, Steno-typist and Typist are

made on the same date, the seniority accorded by the Appointment Committee shall be taken.";

(5) in rule 6, in the tabular column, after the expression "Group III Category 1 Junior Assistant" and the corresponding entries thereto, the following entries shall, respectively, be inserted namely:-

"Group III Category 2-A Typist	2	1";

- (6) (a) rule 8 shall be renumbered as sub-rule (1) of that rule;
  - (b) after sub-rule (1) as so renumbered, the following rule shall be added, namely:-
  - "(2) Every person appointed to the post of Junior Assistant and Typist by promotion shall, within the period of his probation, pass the Foundational Training Course prescribed for the Corporation Service".
