In the letter 1<sup>st</sup> cited, the Register General of High Court, Madras has stated that through these e-Seva Kendra following citizen centre services are provided to Advocates and Litigants viz.,

- Handling inquires about case status next date of hearing and other details.
- Facilities eFiling of petitions right from signing of hardcopy petitions, appending e Signatures, uploading them into CIS and generation of filing number.
- To assist in online purchase of eStamp papers / ePayments.

- Publicize and assist in downloading the Mobile App of e Courts for Andriod and IOS.
- Handling queries about Judges on leave.
- All other quires and assistant in respect of facilities which are digitally available under e-Courts project
- Explaining the method of arranging and holding a video conference court hearing.

In this connection, the High Court Computer committee, High Court Madras in the meeting held on 16.08.2021 resolved to implement e-Seva Kendra in bus stand complex throughout the State for facilitating the General Public to ascertain the information regarding their case status and other details as stated above by approaching e-Seva Kendras. Based on the above backdrop it has been requested to allot 10X15 sqft. space in bus stand complex throughout the State for establishing e-Seva Kendras to provide e-Court services to the Advocate, Litigants and General Public so as to ensure access to justice for all.

Hence, the commissioners concerned (as per list) is hereby instructed to allot measuring 10 x 15 sq.ft. space or a shop in bus stand complexes for establishing e-Sewa Kendras to provide e-Court Services by following due procedures. A report shall be sent to this office before 20.01.2023.
