Environmental Screening Report**

1. Project Town: Namakkal Municipality

2. Sub-Project : Providing/Improvement of Roads with SWD under TNSUDP

3. Brief Introduction& Background

Namakkal Municipality is a Selection grade Municipality with 39 wards. The town has the total extent of 55.24 Sq.Km. The population of this town as per 2011 census is 119491. 9 village panchayats adjoining the town included with the Municipality as per GO.(MS) 22 MAWS dated 21.10.2010.

4. The Project Objectives and Need

Namakkal Municipality has a total road length of 417.35 Kms, Many roads in the old town and added areas have been damaged and it should be laid. In added areas storm water drains has also to be constructed.

5. Proposed Project

Namakkal Municipality has proposed to lay roads which are maintained by ULB and Storm Water Drains in the added areas proposed to lay roads which are damaged. In this project, 10 Bituminous roads of length 7.02 Kms has to be renovated and 26 Earthen roads of 10.28 Kms has to be provided with BT surface. The total SWD of length 7.46 Kms has to be constructed newly within the Right of way of 24 roads in this project and it will not require any land acquisition. For remaining roads SWD already exists. The details of the Roads and SWD are as follows,

The proposed storm water drains will be connected to existing road side storm water drains.


7. Permissions/ Clearances
