Points Discussed:

- The Municipal Commissioner, Namakkal Municipality explained the outline of the Proposed Improvement of Roads with SWD under TNSUDP.

- The Municipal Engineer explained the existing status of the roads and proposed improvement of roads and drains
- The Municipal Engineer explained that Namakkal Municipality has a total road length of 417.35 Kms. Due to implementation of Water Supply Improvement Scheme many roads in the added area have been damaged and it should be laid again. In added area due to non provision of UGSS storm water drains has to be constructed.
- The Municipal Engineer explained that in this project 10 Bituminous roads of length 7.02 Kms has to be renovated and 26 Earthen roads of 10.28 Kms has to be laid newly. The total SWD of length 7.46 Kms has to be constructed newly within the Right of way of 24 roads in this project and it will not require any land acquisition. For remaining roads SWD already exists.
- Various features such as Residences, schools, hospitals, religious features, water bodies(lakes)are present near the proposed roads. But no tree cutting and waste handling involved in the project.
- River crossing does not occurs in this project. During construction management measures will be followed.
- All the proposed roads belongs to Namakkal Municipality. So there is no need to sought permission or clearance from any other department for laying of roads.
- The roads and storm water drains will laid on right of way and there is no need for encroachment/acquisition of land. If any impacts identified /encountered during the implementation of the project will be mitigated as per Social Safeguards.
- It was explained to the Public that during construction management measures will be followed and project will be implemented without any disturbance to the Public.
- The stake holders accepted the facts and the meeting had concluded.
