ORDER:

In the reference 2nd cited, the Tamil Nadu State Election Commission has issued instructions with regard to installation of CCTV in all Polling Stations / Counting Centers / Strong Rooms and installation of Web – Streaming in the Critical and Vulnerable Polling Station in the ensuing Urban Local Body Elections.

In addition to that the Commission has issued instructions to record the events during filing of nomination through Videography in the reference 3rd cited.

In the reference 4th cited the High Court of Madras in its Judgment on W.P.No.27138/2021, Order dated 03.01.2020 has directed "to the respondent State Election Commission to ensure compliance of the guidelines issued by them for holding free and fair election of the Urban Local Bodies in the State of Tamil Nadu. The State Election Commission would cover the election under the CCTV from the stage of nomination by the candidates, followed by the polling of votes and after the polling, videograph the area of the strong room inside and outside and finally, counting of votes and declaration of resulted thereupon".

As per the tender notice 7th read above, state wide tenders were invited on 20.01.2022 by online and offline and two envelope method as per the Tender Transparency Act, 2000 (TTA), were also followed.

As indicated in the 9th and 10th read above, 2 (Two) tenders were received and as per the recommendations of the evaluation committee, the technical bid submitted by M/s. I Net Secure Labs Pvt, Arumbakkam, Chennai. Ltd is technically qualified.

On the opening of the price bid on 21.01.2022 at 5.18 PM M/s. I Net Secure Labs Pvt, Arumbakkam, Chennai quoted the Rate of **Rs.1,01,44,176.00/- (Rupees One Crore and One Lakh and fourty four Thousand and One Hundred and Seventy Six only)** and the same was accepted. Hence the work order issued to the said successful bidder, M/s. I Net Secure Labs Pvt, Arumbakkam, Chennai to execute the Installation of Video graphing, Live web streaming and CCTV arrangements at polling stations, counting halls, Counting Premises, Strong Room, Control Room, DEO Office, Returning Officer and Assistant Returning officer (ARO offices) for General Elections to Urban Local Bodies, 2022 within the jurisdiction of Regional Directorate of Municipal Administration, Chengalpattu.

TERMS AND CONDITIONS:-

1. Prepare a Project Plan in Consultation with the Nodal Officer.
2. Mobilization of personnel to take up the work.
3. Deliver the services & deliverables as per the contract terms & conditions.
4. Conduct of trial runs to see that the we streaming from the identified locations to ensure whether the complete process goes smoothly without any bottlenecks and rectification of the same where necessary.
5. Conduct of live run / recording to see that the web streaming from the identified locations goes thro' smoothly without any bottlenecks on the days of polling.
6. Provide all the Urban Local Body wise and polling station wise log details of live Video streams with downtime / up time.
7. On Completion of the election process, handing over of the transmitted data to the Client (DEO's office) and software in a suitable backup devise to view the same as and when required.
8. Provision of necessary server with system software licenses, storage capacity and internet band width in a secured cloud environment.
9. Facilitate the bidder to ensure that the internet service provider extends the good support in the performance of the connectivity during the election process.

10. An agreement to be executed to the value of Rs.100/-stamp paper within three days from the date of this work order.


Contract Period:
