ORDER :

Based on the recommendations of the Sixth State Finance Commission, vide the Government Order first read above and Government in the G.O. 2nd read above have accorded sanction for the release of 20 Municipal Corporations a sum of Rs.1253,65,17,857/- and 138 Municipalities a sum of Rs.1455,85,36,428/- as Devolution of 6th SFC to the Corporations and Municipalities for the months of **April 2024 to January 2025**.

As per Sixth State Finance Commission's recommendation the following criteria and weightages is adopted for sharing of 6th SFC devolutions to Urban Local Bodies.

a) Population as per 2011 census	:65%
b) Area	:15%
c) Proportion of Slum Population	:20%
Total	:100%

As per the Government Order 2nd cited, the due on the first instalment of interest free ways and means advances for the month of **August 2024** is recovered from the Devolution grant to the respective Corporations (Coimbatore&Salem) and same will be remitted to the Government Head of Account.

Further, an amount of Rs.100,00,000/- has been deducted towards the advance payment made to Salem and Dindigul Corporations vide G.O.Ms.No.37, MA&WS(MA2)dt:4.2.21 and G.O.Ms.No.87, MA&WS(MA2) dt:24.2.2021.




